



Our female connector (item number 2020-102) is designed for seamless electrical installations. Strip lengths must be between 9 and 11 mm when connecting conductors to this female connector. Pluggable rail-mount terminal blocks are primarily found in switchgear units and control systems, most notably in railroad technology. These innovative systems combine the benefits of rail-mount terminal blocks and connectors for a flexible and reliable wiring system. You also have the option of pre-assembling installations, which not only makes production but also installation, operation, and maintenance more efficient and cost-effective. This product features conductor terminals and utilizes Push-in CAGE CLAMP®. Our Push-in CAGE CLAMP® is a universal, maintenance-free connection solution for all conductor types, boasting a key feature: It allows direct insertion of both solid and fine-stranded conductors with ferrules without needing tools. No preparation is required; for example, crimping the conductor's ferrule is not necessary. The dimensions are (7.7 x 40.5 x 22.4) mm (width x height x depth). Depending on the conductor type, this female connector is ideal for conductor cross sections ranging from 0.14 mm² to 1.5 mm².

An operating tool is used to operate this female connector/socket.

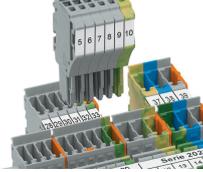
Coding



Insert coding pin into the corresponding slot and twist it off.

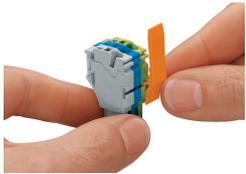


Coding a female plug: remove coding finger using a suitable tool.
