4. Confirmation of compliance status by our suppliers is either because the products do not contain any of the restricted substances referred to in Article 4(1) of the RoHS Directive at concentrations in excess of those permitted under the RoHS Directive or because removal of the restricted substances is not technically possible and their existence in the products at levels in excess of these concentrations is allowed as one of the particular applications listed in the Annex to the RoHS Directive.
