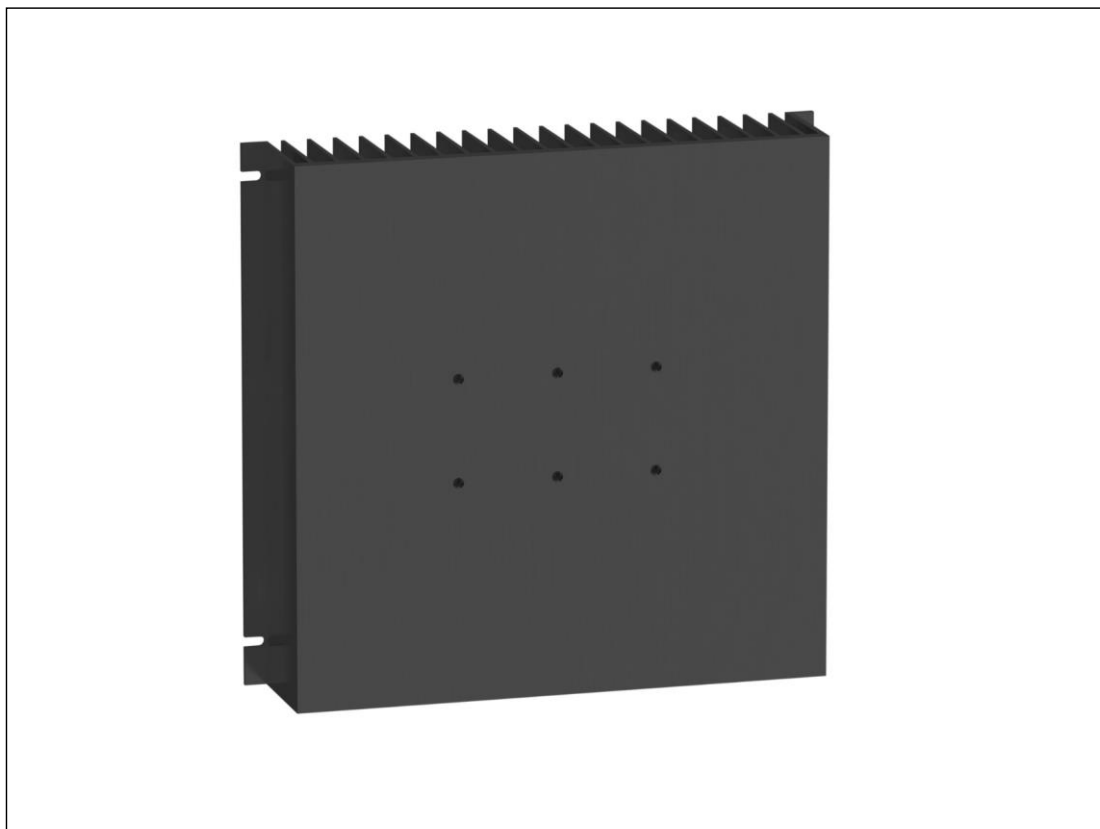

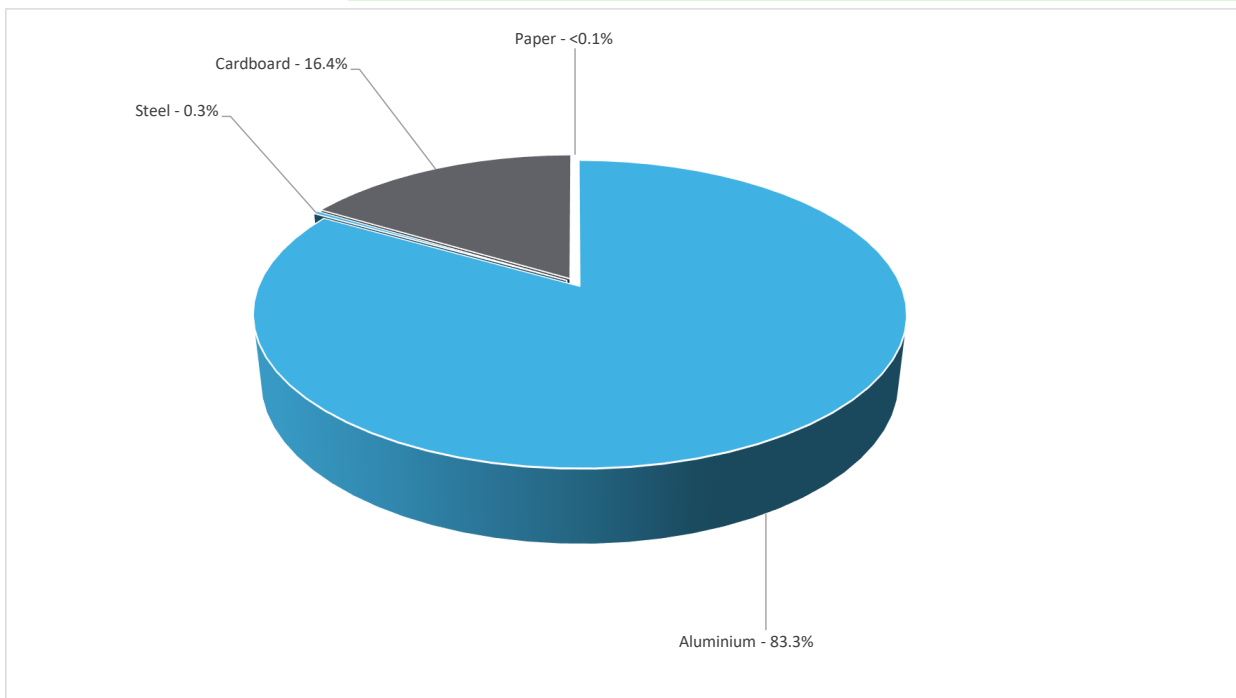


## General information
