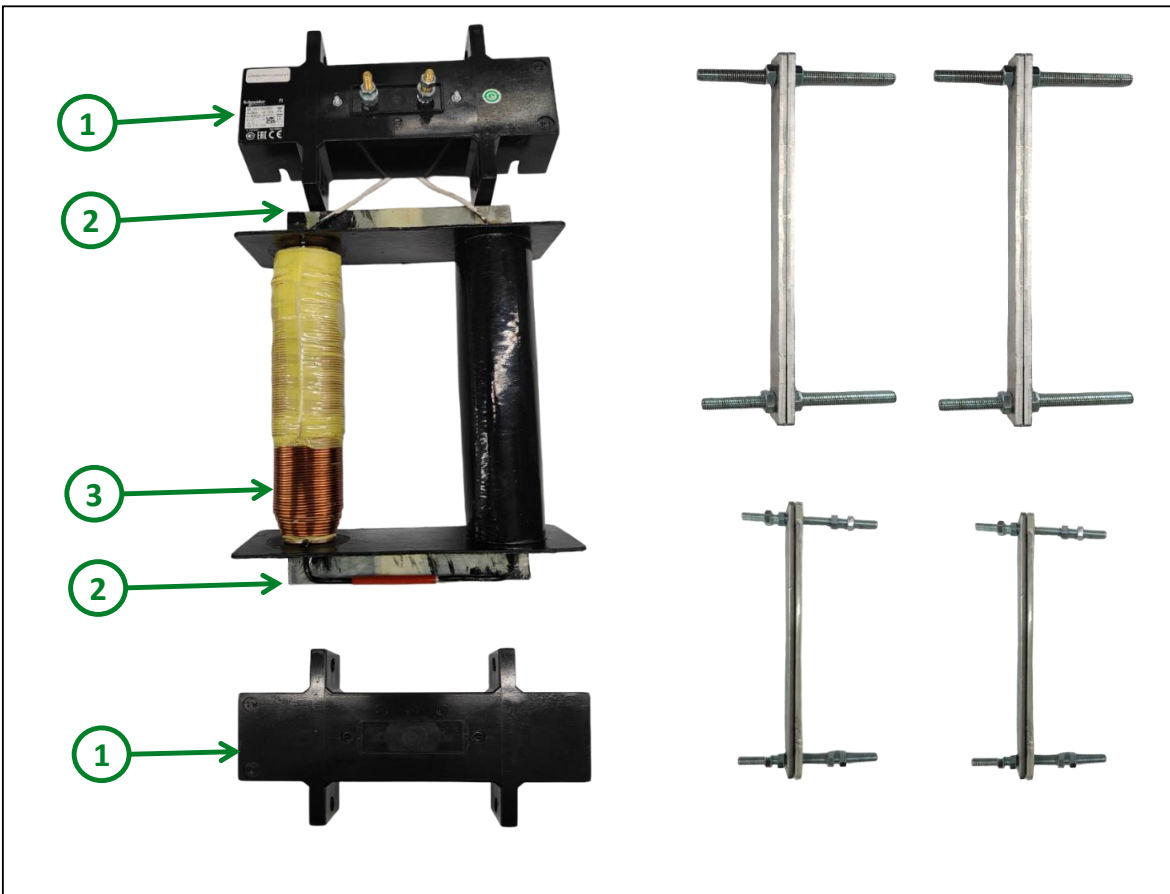
Potential disassembly risks
