REMARK

The specified products were not yet assessed for compliance with all aspects as inserted in the Dutch Drinking Water Decree and outlined in the "Regeling materialen en chemicaliën drink- en warm tapwatervoorziening" ("Regulation materials and chemicals drinking water and warm tap water supply"), implemented 19 July 2011. As specified in the mentioned regulations, a transition period applies. As soon as the final policy has been defined the products shall be tested in accordance with Clause 4.3.1 of Kiwa evaluation guideline BRL-K668/03.

APPLICATION AND USE

Shower hoses for sanitary taps according to EN 1113 are intended for application in drinking water installations with a dynamic pressure of 50 kPa to 500 kPa and a maximum water temperature of 70°C. The recommended limits for correct operation are a dynamic pressure of 100 kPa to 300 kPa and a maximum water temperature of 42°C.

MARKING

The Kiwa®-mark products are marked with the word mark "KIWA". Place of the mark: on the shower hose.

Compulsory specifications: • name or mark of the manufacturer.

Method of marking:

- non-erasable;
- visible after assembly.
