This Reference Product comes from a site that observes the applicable legislation for industrial sites.



### ■ DISTRIBUTION

The Group's products are distributed from logistics centres located to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 780 km, essentially by road, representing a marketing in Europe.

Packaging is compliant with European directive 2004/12/EC concerning packaging and packaging waste. At the packaging end of life, its recycling rate is of 96 % (as % of packaging weight).



### ■ INSTALLATION

For the installation of the product, only standard tools are needed.



### ■ USE

### END OF LIFE

The product end-of-life factors are taken into account during the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse. This product falls within the scope of the WEEE directive (2012/19/EU). Therefore it must be processed through local WEEE recycling/recovery channels.

**• Elements to process specifically:**

In accordance with the requirements of this Directive, the following components must be removed and sent to specific channels for processing which comply with the WEEE Directive 2012/19/EU:

- electronic cards more than 10 cm<sup>2</sup> : 30 g
- external electric cables : 33 g

**• Extended producer responsibility:**

The sale of this product is subject to a contribution to eco-organisations in each country responsible for managing end-of-life products in the field of application of the European Waste Electronic and Electrical Equipment Directive.

**• Recyclability rate of the Reference Product:**

Calculated using the method described in technical report IEC/TR 62635, the recyclability rate of the product is estimated at 70 %. This value is based on data collected from a technological channel operating on an industrial basis. It does not pre-validate the effective use of this channel for the end of life of this product.

- plastic materials (excluding packaging) : 43 %
- other materials (excluding packaging) : 8 %
- packaging (all types of materials) : 19 %



### ENVIRONMENTAL IMPACTS

The evaluation of environmental impacts examines the stages of the Reference Product life cycle: manufacturing, distribution, installation, use and end-of-life. It is representative from products marketed and used in Europe, in compliance with the local current standards.
