



FLEXA Conformity Declaration

Restriction of Hazardous Substances in Electric and Electronic Equipment (RoHS)

Our products comply with the requirements of the Directives 2002/95/EC, 2011/65/EU and 2015/863, and DO NOT contain the mentioned materials above the permissible limits: lead, cadmium, mercury, hexavalent chromium, polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE), bis(2-ethylhexyl)phthalate (DEHP), butyl benzyl phthalate (BBP), Dibutyl phthalate (DBP) and diisobutyl phthalate (DIBP).

REACH and Substances of Very High Concern (SVHC)

REACH (EC 1907/2006, Registration, Evaluation, Authorization, and Restriction of Chemical Substances) directive aims to terminate the lack of data regarding the characteristics of chemical substances and their effects on man and environment for the chemicals produced or imported in Europe from the volume of 1 ton/year. Polymers and End-Products (such as all Flexa Products) are not subjected to REACH registration. However, REACH contains the SVHC list (Substances of Very High Concern), which lists harmful substances, which might become compulsory for registration (periodically updated by European Chemical Agency (ECHA), last update on 25.06.2020: <http://echa.europa.eu/web/guest/candidate-list-table>). According to the latest information from our suppliers and to our best knowledge our products DO NOT contain more than 0.1 wt.% of any substance from the SVHC Candidate List.

Compliance with Conflict Minerals Laws and Regulations

Flexa's employees are committed to sourcing responsibly. In particular, we undertake not to knowingly buy so-called "Conflict Minerals" (raw materials containing the minerals cassiterite, columbite-tantalite, gold, tantalum, tin, tungsten, or wolframite that directly or indirectly finance or benefit armed groups in the Democratic Republic of the Congo ("DRC") and adjoining countries, restricted by Section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act - September, 2010, <http://www.conflict-minerals.com/>). The DRC Countries are presently Angola, Burundi, Central African Republic, Democratic Republic of the Congo, the Republic of Congo, Rwanda, South Sudan, Tanzania, Uganda, and Zambia.


EC Declaration of Conformity (CE marking)
