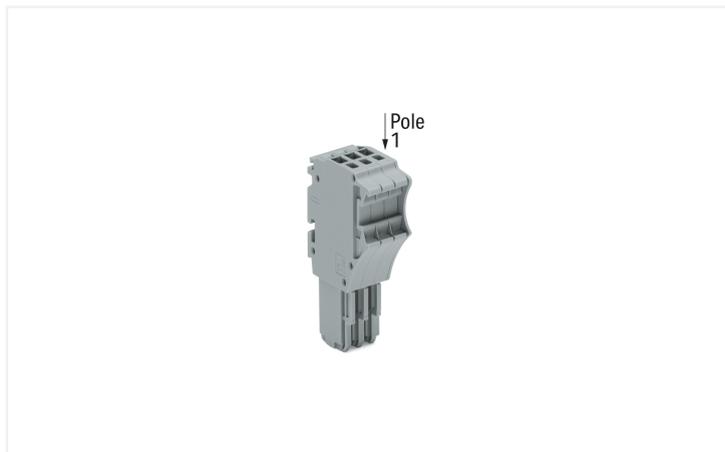




Our female connector (item number 2020-103) simplifies electrical installations. Ensure that the strip lengths are between 9 and 11 mm when connecting conductors to this female connector. Pluggable rail-mount terminal blocks are primarily found in switchgear units and control systems, most notably in railroad technology. These innovative systems combine the properties of rail-mount terminal blocks and connectors for a flexible and reliable wiring system. You also have the option of pre-assembling installations, which not only makes production but also installation, operation, and maintenance more efficient and cost-effective. This product features conductor terminals and utilizes Push-in CAGE CLAMP®. Push-in CAGE CLAMP® connection technology is ideal for connecting all conductor types. It allows direct insertion of both solid and fine-stranded conductors with ferrules without needing to use any tools—all thanks to its pluggable design. The item's dimensions are (11.2 x 40.5 x 22.4) mm (width x height x depth). Depending on the conductor type, this female connector is suitable for conductor cross sections ranging from 0.14 mm² to 1.5 mm².

An operating tool is used to operate this female connector/socket.




Coding



Insert coding pin into the corresponding slot and twist it off.




Coding a female plug: remove coding finger using a suitable tool.
