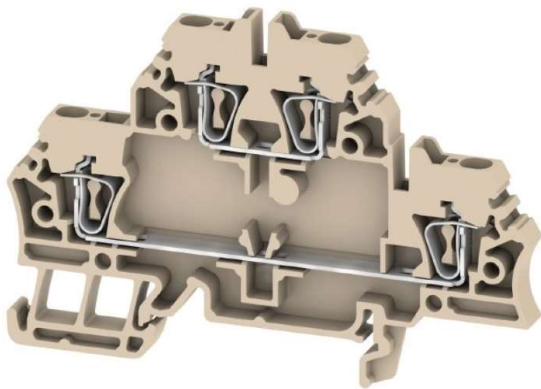

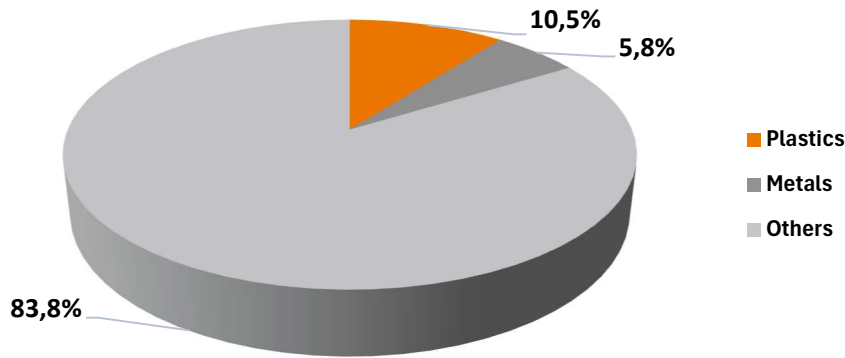

Its high-quality insulating materials and robust spring-clamp connection technology ensure secure, long-term electrical contact. With two stacked connection levels, the terminals allow multiple conductors to be safely joined or connected within a compact design.
Functional unit	Connect 4 clamping units between 2 or more wires for a rated cross-section 14,5 mm ² , with rated voltage 500 V, rated current 20 A, and a voltage drop 2,46 mV, according to the appropriate use scenario, and for the reference service life of the product of 20 years.

Manufacture	<p>This stage includes the manufacturing of the product and its packaging as well as the transport to the manufacturer's last logistics platform located in Hörselbach-Hainich (Germany). The final assembly site is located in Germany and has an ISO 14001 and ISO 50.001 certified environmental management system. Transport packaging, used in addition to product packaging when required for delivery, is excluded from the system boundaries.</p>
Distribution	<p>The shipment is made from the distribution centre to the customer by truck. The transport route to the customer was assumed to be 3500 km by lorry.</p>
Installation	<p>Only the disposal of the packaging is considered in this phase, as the installation is carried out manually with non-electrical tools.</p>
Use	<p>No maintenance or utilities are required during use. The power consumption was calculated according to the use scenario below.</p>
End of Life	<p>The end-of-life stage is modelled based on the data from Eurostat. The transport route to the disposal company was assumed to be 1000 km by lorry.</p>
