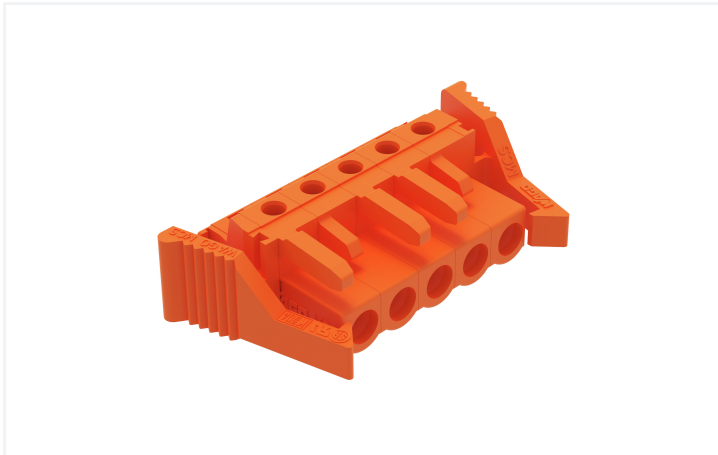


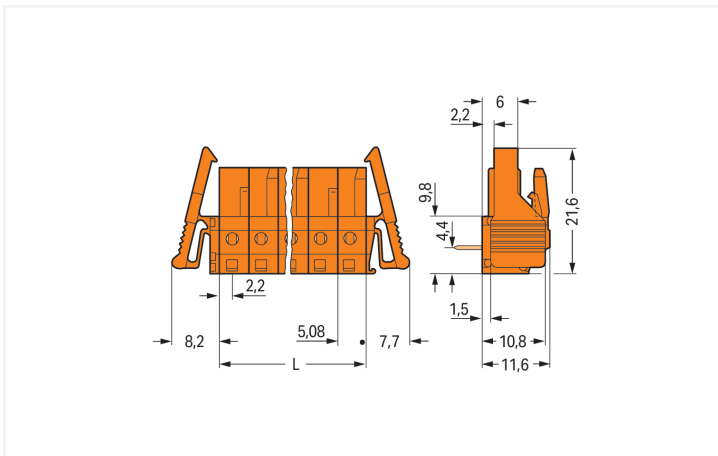

The contact surface is coated with tin. THT is used to assemble the pcb connector.
