

REACH - Regulation (EU) No 1907/2006

REACH is the main EU law to protect human health and the environment from the risks that can be posed by chemicals. The regulation governs the registration, evaluation, authorisation and restriction of chemicals (REACH stands for 'the **R**egistration, **E**valuation, **A**uthorisation and **R**estriction of **C**hemicals').

As end (**downstream**) **users** Finder maintains active communication along its supply chain, keeping a close eye on the Safety Data Sheets (SDS) of the raw materials it uses, and periodically requesting proof of compliance from its suppliers. In accordance with the obligation under Article 33 of the REACH regulation, we commit to reporting to our customers the possible presence of substances classified

as SVHC (Substances of Very High Concern) above the concentration limit of 0.1% w/w and included in the Candidate List: (<https://echa.europa.eu/en/candidate-list-table>). Should the regulation restrict or prohibit the use of certain substances in the market, and in order to ensure the continuity, quality and performance of our products to our customers, we practise an ongoing commitment to the research and development of alternative processes and substances.

Adherence to the above procedures are laid-out in the environmental and safety policies in the Company's Quality Management Systems in accordance with ISO 14001 and ISO 45001.

We declare:

- that the products supplied fall under the definitions provided in Article 3.3 of the REACH regulation and do not release any substances under normal or reasonably foreseeable conditions of use;
- that it is not required to register substances used in the production processes;
- that we will maintain the necessary procedures and actions to ensure compliance with the requirements of the REACH regulation.

We also specify that:

- there are no substances classified as SVHC (Substances of Very High Concern - <https://echa.europa.eu/en/candidate-list-table>) in our products in concentrations greater than 0.1% by weight, with the exception of the items in Table 1 for which SCIP notification has been made.
